ADMISSION TO Ph.D. PROGRAMME 2018

Application on prescribed form from eligible candidates are invited for admission to Ph.D. Programme in Al-Falah University, Faridabad, as per UGC (Minimum Standards & Procedure for award of M.Phil./ Ph.D. Degree) regulations 2009 dated 01.06.2009 published in the gazette of India dated 11 July 2009 and modified as UGC Ph.D. Regulations 2016 published in the gazette of India dated 5th July 2016.

The university Regulations Ph.D. regulation 2018, are based on the University Grants Commission Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degrees) Regulations, 2016.

Eligibility Criteria for Admission to Ph.D. Programme:

1. Eligibility Criterion for Admission

- 1.1 A candidate shall be eligible for admission to the programme of study leading to the degree of Doctor of Philosophy if he/she has obtained M.Phil. or Master's degree of the university or a degree recognized by the university for this purpose as its equivalent in the relevant field or allied subject with at least 55% of marks (with a minimum Cumulative Grade Point Average (CGPA) of 6.0 on a 10 point scale). Candidates belonging to SC, ST, Minority/differently able persons shall be eligible for relaxation up to 5% of minimum eligible marks.
- 1.2 Provided, that the cases of students who have passed the examination outside the Indian universities and who may not have obtained a Master's or M. Phil. Degree may be considered for admission to the course, subject to their equivalence as adjudged by the AIU foreign university degree equivalence list.
- 1.3 Candidates possessing a Degree considered equivalent to M.Phil. Degree of an Indian Institution, from a Foreign Educational Institution which is approved, recognized or authorized by AIU, shall be eligible for admission to Ph.D. programme.

2. Entrance Test:

Entrance Test is mandatory for all candidates. The entrance test will be for screening the applicants in order to determine their suitability for admission to Ph.D. Programme of the concerned department. Qualifying the entrance test will entitle them to appear in the interview. The entrance test shall be based on two sets of question papers as specified below. Both test papers will be conducted back to back.

The following category of candidates shall be exempted from appearing in the Entrance Test for the Ph.D. Programme.

- i) Candidates who have qualified UGC-NET Test or Gate in last three years.
- ii) Candidates have successfully completed M.Phil. Programme of two years' duration from a recognized university / institution.
- iii) The teacher fellowship holders of the recognized college / university / institution provided that the competent employing authority issues a No Objection Certificate to the candidate to join the Ph.D. Programme and an undertaking that the candidate will be granted leave for the duration of the required course work.
- iv) ICCR sponsored candidates.
- v) NET/GATE qualified students (of last three years) and current scholarship holders of National scheme (of UGC / CSIR/ PM scheme) need not appear for test, but their selection to Ph.D. programme will be subjected to the approval of BORS after reviewing their synopsis/ proposed project work and facilities available in the university.
- vi) The candidates seeking an exemption from the Entrance Test shall have to submit the proof in support of their exemption.
- vii) The candidates who have been granted exemption from appearing in the Entrance Test shall have to follow rest of the admission process as per the schedule and fulfil all other requirements as per the Ordinance / Rules / Regulations for the Degree of Doctor of Philosophy of AFU.

Paper 1 (The First Set of Question Paper): Duration: 1 Hour

50 multiple choices (Objective type questions) – 100 mark. Each Correct answer 2 marks and each wrong answer negative one marks.

- i. Questions will be, as suggested by UGC, on Teaching and Research aptitude, Reasoning, Comprehension, Communications, Language, Data interpretation, ICT, People and Environment, writing and analytical skills, and contemporary issues relevant to research and higher education system- Governance, Polity and administration.
- ii. Examiner may give other 5-10 questions (MCQ) in related to above syllabus with a choice to the candidates.

Paper 2 (The Second Set of Question Paper): Duration: 1 Hours

- iii. The Question Paper 'B' of the shall be devoted to knowledge of the subject in general in the area concerned, such as Engineering and Technology/ Sciences/ Medical Science/ Life Sciences / Management / Education and the advanced knowledge of subject concerned and that of the specialization, if any. It may also include a set of general aptitude test questions. It will be of 100 marks. The paper B will include multiple choices (objective type) questions MCQ and a set of subjective types/ numerical answer type (*NAT*) questions.

Criterion to Qualify for Interview:

The candidates obtaining at least pass marks separately in Paper 1 and Paper 2 in the Entrance Test shall qualify for the Interview.

Interview:

Qualified candidates shall be called for an Interview before the Board of Research Studies (BORS).

The list of selected candidates as approved by BORS and Vice Chancellor, AFU will be displayed by the Coordinator, Ph.D. Programme, on university notice Board/ website. Selected candidate will be informed by other digital means.

Course Work:

All the candidates provisionally admitted to Ph.D. Programme will be required to complete the prescribed course work of at least one semester duration. If a candidate is M.Phil. in the same area/subject he/she may be given exemption for Course work.

Duration of the Programme:

Ph.D. programme shall be for a minimum duration of **two and half years** after the successful completion of the course work and a maximum of six years.
