



**NOTICE INVITING EXPRESSION OF INTEREST (EOI) FOR PROVIDING
SECURITY SERVICES AT AL-FALAH UNIVERSITY**

Al-Falah University invites Expression of Interest (EOI) from reputed, experienced, and financially sound agencies/firms engaged in providing professional security services for deployment at the University Campus and its associated facilities.

Scope of Services:

The selected agency shall be responsible for providing trained and experienced security personnel, including Security Guards and Supervisors, for ensuring the safety and security of university property, students, staff, visitors, and assets. The services may include:

- Access control and gate management.
- Patrolling and surveillance of the campus.
- Protection of University property and assets.
- Crowd management during events and examinations.
- Maintenance of security records and incident reporting.
- Monitoring of activities going on in the campus through CCTV
- Any other security-related duties assigned by the University.

Eligibility Criteria:

Interested agencies should:

1. Be legally registered and engaged in security services for at least three years.
2. Be empanelled by Directorate General Resettlement (DGR) for Haryana
3. Possess a valid Private Security Agencies Regulation Act (PSARA) Licence.
4. Have experience of providing security services to Universities, Educational Institutions, Government Organizations, Public Sector Undertakings, or reputed private organizations.
5. Have valid registrations under GST, EPF, ESI, Labour Laws, and other statutory requirements.
6. Have adequate manpower and infrastructure for deployment and supervision of security personnel.
7. Not have been blacklisted by any Government Department, PSU, Autonomous Body, or Educational Institution.
